



# The IRA Charitable Rollover

If you are age 70½ or older the IRA Charitable Rollover provision in the tax code can be a savvy way to make a gift to support your favorite Aurora hospital or program. This kind of gift will count as part of your Required Minimum Distribution (RMD). You can make an IRA Charitable Rollover gift through a direct transfer from your IRA to Aurora Health Care Foundation. Once you have instructed your IRA account administrator to make the transfer, please let us know what Aurora hospital or program you choose to support.

## Benefits of an IRA Charitable Rollover Gift

- It allows you to support your favorite Aurora hospital or program.
- The distribution from your IRA does not count as taxable income.
- You receive tax benefits even if you don't itemize.
- You may use it to fulfill a pledge.

## Special Considerations when arranging an IRA Charitable Rollover Gift

- The distribution must come directly from your IRA account to Aurora Charitable Foundation.
- The maximum IRA Charitable Rollover amount is \$100,000 per person.
- We have sample language to assist you in directing your IRA account administrator to make this kind of distribution to Aurora Health Care Foundation.

## Situations to Avoid

- **DO NOT** take the funds out of your IRA and then write a check to us or your Aurora hospital/program. This will nullify the tax benefits of the Charitable Rollover.
- Rollover funds cannot be used to receive any benefit, such as gala tickets, in exchange for the gift.
